## Correction - December 2001 Newsletter Wellness Benefits: FirstSource PPO Group

Arkansas Blue Cross and Blue Shield previously published an article in the December 2001 issue of *The Providers' News* regarding Wellness Benefits for FirstSource PPO Groups.

# ABCBS Updates Provider Contracts

It has been almost 15 years since Arkansas Blue Cross and Blue Shield made comprehensive updates to its provider contracts. As you might imagine, after so much time and with all of the evolving complexities of our industry, some of these contracts have grown outdated or inadequate.

In an effort to update our agreements as well as incorporate changes that have been mandated by state and federal regulations, ABCBS has created a new contract that should provide clarity to our contractual relationship.

Essentially, the new form brings our contractual language into greater consistency with how we currently operate. The new form also addresses regulatory changes, including such new ones as the HIPAA Privacy Rules, which will take effect in 2003. The purpose of these new agreements is to update contract language, not change the current rate of reimbursement.

Contract updates for the ABCBS participation level Preferred Payment Plan (PPP) and Hospital Reimbursement Program (HRP) were delivered in January via contract amendments. These amendments will be effective June 1, 2002.

Not all types of participating providers are a part of this contract-updating project. ABCBS is currently addressing the following provider types: Ambulatory Surgery Centers, Chiropractors, CRNAs, Dentists, Hospitals, Optometrists, Physicians (MDs and DOs), Podiatrists, and Psychologists. If you fall into one of these categories and have not received the applicable PPP or HRP contract amendment, please contact your regional Network Development Representative.

# AHIN (Advanced Health Information Network) and VRU (Voice Response Unit) Systems

During the past few months, Arkansas Blue Cross and Blue Shield has experienced an extreme increase in the number of calls to customer service. We do appreciate your calls and sincerely apologize for the inconvenience in having to hold. With each call, we try to devote as much time as needed to answer all questions and find solutions to each problem.

For faster service when checking on contract benefits and claim status, we recommend the AHIN (Advanced Health Information Network) and VRU (Voice Response Unit) systems. The VRU is an automated system available for use by a provider via the telephone. The AHIN system is a shareware program accessed through the net.

If you are not currently using the AHIN system and would like information regarding this shareware program, please your Network Development contact Representative. An example of the AHIN program is available on the ABCBS web site at www.arkbluecross.com. If you are presently using the AHIN system and experiencing problems, please contact Diane Lamm at (501) 399-3942.

# AHIN Claim Filing Procedure Reminder

If your software contains a suffix field in the demographic portion for names containing, Jr. Sr. or IV, please use this field to add suffix information. However, if your software does not contain a suffix field, file the claim without Jr., Sr., or IV.

**Exception**: If the ID card for example has listed "SmithJr" as the last name on the card with no space in between the last name and suffix, file "SmithJr" in the last name field.



# Arkansas State Employees (ASE) and Public School Employees (PSE) – Update

#### Important Facts and Procedures:

**PPO Vs PPP providers:** In-network providers for the Arkansas State and Public School Employees Blue Cross PPO Plan includes all providers in the PPP network. Therefore, if you are a PPP provider, you are an in-network provider for members of the State and Public School Employees Plan covered under the ABCBS PPO.

**Referrals – Health Advantage HMO:** Health Advantage HMO members seeking treatment from a specialty provider must have a referral from the member's PCP to see in-network providers or an approved out-of-network referral from Health Advantage for benefits to be paid.

**Referrals – Health Advantage POS:** Health Advantage POS members seeking treatment from a specialty provider should have the same referrals in place as the HMO members to receive maximum payment for benefits. If the referrals are not in-place, the payment reduction could be as much as 40%.

**Information on Electronic Claims:** Providers submitting electronic claims must have the member information exactly as it appears on the identification card. If you have seen patient "Bob Doe" but his name on our files is "Robert Doe", the claim must be submitted with patient name "Robert Doe" or the claim will be rejected. Hyphenated or unusually long names may present problems and should be addressed with a customer service representative following any AHIN denial message. Always make a copy of the current member identification card.

**Using In-Network Ancillary Providers:** Central Region Health Advantage providers should use only in-network ancillary providers. For example, all lab work sent from your office to an outside lab should be sent to Arkansas Medical Labs or Pathology Laboratory of Arkansas. If you use <u>any</u> out-of-network ancillary providers, the member will be responsible for the entire bill (HMO members) or part of the bill (POS members). For the most current copy of the Health Advantage participating provider directory, please contact Customer Service or your Network Development Representative.

**Other Ancillary Providers:** Health Advantage providers, other than those in Central Region, should refer to the ABCBS web site, contact a Customer Service Representative, or contact your Network Development Representative for appropriate in-network and out-of-network ancillary providers. The **BLUE GUIDE** was distributed by Health Advantage in November 1998 to primary care physicians and specialty physicians who provide care for selected disease processes targeted by the <u>Clinical Practice</u> <u>Guidelines</u> contained in the **BLUE GUIDE**.

With our resources shifting to member focused Health Education Programs and our desire to provide you with the most evidence based guidelines, Arkansas Blue Cross and Blue Shield and Health Advantage have decided to discontinue updating and revising <u>Clinical</u> <u>Practice Guidelines</u> distributed for inclusion in the **BLUE GUIDE.** The Preventive Health Guidelines will be maintained on the Health Advantage Web Site.

Arkansas Blue Cross and Blue Shield, Health Advantage, and USAble Administrators will continue to develop community-based programs with a focus on our members and your plan of care. As a part of this effort, we are pleased to reacquaint you with our Health Education Programs.

Our community-based, disease-specific health education programs emphasize self-management techniques and include national and local health-education resources and assistance with member health-plan benefits.

Program highlights include:

- Voluntary Health Risk Survey.
- One-on-one contact with a regional registerednurse case manager based on risk stratification.
- National and local health care resource lists.
- Tip sheets on health education self-help measures for use at home.

National and local health care resource lists are available for your reference on the ABCBS web site (www.arkansasbluecross.com) and Health Advantage web site (www.healthadvantage-hmo.com) under the Members/ Health Plans & Services/ Value Added Services/ Health Education Programs tabs.

Specialty providers will be notified routinely of new and existing Health Education Programs. The national and local health care resource lists are included in the member health education packets.

# Corrected Bill Submission Form

Arkansas Blue Cross and Blue Shield, Health Advantage, and USAble Administrators have developed a new form for Arkansas providers when submitting corrected bills. Effective March 1, 2002, the <u>Corrected</u> <u>Bill Submission Form</u> (page 10) must be completed and attached to all corrected bills submitted by Arkansas providers.

What is a "Corrected Bill"? A "Corrected Bill" is a claim that has been previously submitted to the plan for processing and has been finalized (paid) or denied. A corrected bill must be identified by the words "corrected bill" written on the face of the original claim, and a <u>Corrected Bill Submission Form</u> must be attached to the claim. If a <u>Corrected Bill Submission Form</u> is not attached, the claim will be returned to the provider unprocessed.

The purpose of this change is to expedite processing time by assisting in identifying the actual correction and the reason for the correction. Copies of the <u>Corrected</u> <u>Bill Submission Form</u> were enclosed in several previous remittance advices. Presently, the form can be accessed and printed from the ABCBS web site (www.arkansasbluecross.com).

## Coverage Policy now on Web sites

Coverage Policy has now been added to the ABCBS and Health Advantage web sites. The purpose of the Coverage Policy is to inform members and their physicians about what is and is not covered under Arkansas Blue Cross and Blue Shield insurance contracts or Health Advantage health plans.

Within the Coverage Policy section, users may search by key word, policy title, policy number or procedure code. In addition, users may access explanations of the following:

- What Is the Coverage Policy?
- How Coverage Decisions Are Made.
- What Is a CPT Code?

The new Coverage Policy section may be found in the Members and Providers sections of ABCBS web site (<u>www.arkansasbluecross.com</u>) and Health Advantage web site (<u>www.healthadvantage-hmo.com</u>).

## **Dental Claims Submission – PSE:**

Effective 10/01/01, Arkansas Public School Employees (PSE) no longer have preventive dental benefit on their health insurance. For PSE who have dental insurance with ABCBS, it is essential that dentist file claims using the **members' identification number not the members' social security number.** 

If dental claims are filed using the social security number, the claim **will be denied**. Social security numbers are used for health insurance policies and not dental policies. By using the members' identification number, claims will be processed under their dental policy and not their health insurance policy.

#### <u>Electronic Claim Submission -</u> <u>Arkansas FirstSource PPO Access-Only:</u>

Providers are encouraged to file their claims for Arkansas' FirstSource PPO Access-only groups electronically. <u>Access-Only claims may be submitted to</u> <u>ABCBS along with your Blue Cross, USAble, Health</u> <u>Advantage, FEP, and Medicare claims.</u> See (page 9) for a current list of Arkansas' FirstSource Access-Only groups.

#### Ways to expedite pricing of Access-only claims:

- Please do not send Access-only claims directly to the Third Party Administrator (TPA) unless instructed to do so on the patient's ID card. This will only delay processing and payment of your claim. There are a few groups where Professional claims are submitted directly to the TPA. These are noted on the list of groups.
- 2) Please do not include prefixes, suffixes, or dependent numbers in the ID field on the claim. The "eligibility file" we get from group or TPA contains only the SSN or ID number. <u>Any</u> difference between the ID number on the claim and the ID number on our file will cause the claim to reject because we are unable to determine what group the patient belongs to.

- 3) American Freightways is the only group that has alpha characters in the ID number. For all other groups the ID number should be the same as the Social security Number of the employee. Wal-Mart claims may be submitted with WM prefix but it is not necessary.
- 4) Be sure to include your ABCBS provider number on Access-only claims in field 24K and 33 on HCFA 1500's and in field 51 on UB92 claims. This information is necessary for appropriate handling and pricing of Access-only claims. Using your Tax ID number may cause the claim to reject or payment to go to the wrong provider.
- 5) If paper claims are necessary for Access-Only groups, please submit on RED HCFA 1500 or UB92 claim forms. This enables us to image the claims for more efficient and timely pricing of your claims.

Please note that while you are asked to file your claim initially with Arkansas' FirstSource® PPO for pricing purposes, neither Arkansas' FirstSource® PPO nor Arkansas Blue Cross and Blue Shield nor any of its affiliates are payers of any Access-Only claims, nor do they assume any responsibility for funding or paying any self-funded or Access-Only PPO members' claims. All payment (or denial) responsibility remains with the selffunded health benefit plan or its employer-sponsor, and you must look exclusively to these responsible payers for payment with respect to such claims.

# Injections – Allowance Changes:

Effective April 1, 2002, Arkansas Blue Cross and Blue Shield, USAble, Health Advantage, and AR FirstSource Access-Only will no longer include an administration fee in the allowance for injection and immunization codes.

The allowance for injection and immunization codes will cover only the drug. Providers must bill separately using the applicable administration code to receive reimbursement for administration of the injection or immunization.

Refer to the American Medical Association's CPT Coding book, codes 90782 through 90799 for the appropriate coding instructions.



# Medical Records Vendors:

When a health care provider enlists the services of a vendor (e.g. Smart Corp) to assist them with medical records, it is the provider's responsibility to inform the vendor that ABCBS, Health Advantage and USAble Administrators are not responsible for their fees.

The provider contracts indicate that ABCBS and its subsidiaries are not responsible for payments of medical records when they are requested for claims benefit/payment determination and utilization review programs related to our policyholders. In addition, cost for records requested for these purposes cannot be charged to our members.

# Medi-Pak – Paper Claims Not Necessary:

The submission of paper claims to Medi-Pak is no longer necessary. Effective April 1, 2001, Arkansas Blue Cross and Blue Shield entered into an agreement with Health Data Management Corporation (HDM) that allows for the electronic transmission of both Medicare Part A and Part B claims from all over the nation directly to ABCBS.

If you file a paper claim to Medicare, all you need to do is complete the blocks 9, 9a, 9b, 9c and 9d (other insurance information for the Medigap policy) for Medigap policy information on the HCFA 1500 claims form. Be sure to include the member's Medi-Pak identification number in block 9a, and the claim will be electronically submitted to ABCBS. If you file electronically to Medicare, be sure to include this same information in the appropriate electronic fields.

If you file on the UB92 (HCFA 1450) claim form, be sure to complete blocks 50 (Payer Identification), 58 (Insured's Name), 59 (Patient's Relationship to Insured), and 60 (Patient's ID number).

Please **DO NOT** submit a paper claim to Medi-Pak unless 25 days have passed <u>after</u> you have received payment from Medicare. The 25 days will allow adequate time for the transmission of the Medicare claim to ABCBS and for Medi-Pak to process the claim.

Prior to submitting a paper claim, please verify claim status on AHIN, the BlueLine (VRU), or through Customer Service to ensure the claim is not in process or pending payment from the original crossover.

# <u>Medi-Pak HMO – Non-Renewal:</u>

# Attention: Medi-Pak HMO Participating Providers:

As of January 1, 2002, Health Advantage did not renew the Medi-Pak HMO contract with the Centers for Medicare and Medicaid Services (CMS) (formerly HCFA) for Medicare+Choice. Therefore, Medi-Pak HMO no longer offers Medicare health benefits to our Medicare members in Garland, Hot Spring, Lonoke, Montgomery, Prairie, Pulaski, Saline, White, and Woodruff counties.

It is vitally important that your office is aware of this nonrenewal due to claims filing. Any claims for dates of service January 1, 2002 or after need to be filed directly with Medicare.

There is a 180 day timely filing provision for Medi-Pak HMO claims submission. Therefore, all 2001 dates of service must be submitted by **June 30, 2002**. If a claim or bill for services is <u>not</u> submitted and actually received by Health Advantage within 180 days following the 2001 date of service, the claim will be denied.

Please note this does not affect Health Advantage's other benefit programs or other policyholders, only the Medi-Pak HMO members. This also has no impact on the Medi-Pak Supplemental policies through Arkansas Blue Cross and Blue Shield, and in fact, we expect many of the Medi-Pak HMO members to switch to Medi-Pak at the termination of their Medi-Pak HMO benefits.

# Specialty Medications: Use of one-source prescription supplier

Pharmacy plans throughout the nation are experiencing steep increases in their year to year drug expenditures. This alarming six year cost trend for outpatient medications is increasing the pharmacy percentage of the total medical cost trend.

Arkansas Blue Cross and Blue Shield, Health Advantage and USAble Corporation are also experiencing similar increasing pharmacy cost trends. In an effort to moderate this trend, ABCBS and its affiliates are implementing use of a single-source pharmacy to dispense the specialty self-administered medications listed.

Arkansas Blue Cross and Blue Shield, Health Advantage, and USAble anticipate finalization of this

arrangement with an exclusive vendor by April or May 2002. This pharmacy will specialize in a limited number of high-risk, chronic disease states in order to provide unique service and oversight to those members.

A personal letter and an appropriate newsletter will be mailed prior to the effective date of the change to notify all members, physicians, and pharmacies affected by this change. Members receiving a personal notification letter will also receive an individualized telephone call from an AdvancePCS Specialty RX Case Manager to explain the changes and make arrangements to begin shipment of their medication.

## USAbleAdminArkansas.com Goes Live

**USAbleAdminArkansas.com**, the web site for USAble Administrators customers who have health plans that include products branded with the Blue Cross Blue Shield, made its Internet debut on January 31, 2002. The complete USAble web site address is *http://www.USAbleAdminArkansas.com*. A second site, **USAbleAdmin.com**, which serves customers who do not have Blue-branded products (no cross or shield), went live February 2002.

Operated by a wholly owned subsidiary of Arkansas Blue Cross and Blue Shield, USAble Administrators serves more than 120,000 employees and their family members. USAble Administrators processes claims and manages enrollment and benefits for self-funded groups. Responsibility for all payment or denial of claims, however, remains the exclusive responsibility of the selffunded group health benefit plan or employer-sponsor for the Plan, as USAble Administrators is not a payer and does not fund any claims

The USAble Administrators sites are similar in design and navigation to **arkansasbluecross.com** and **healthadvantage-hmo.com.** Members, employers, providers, and guests have customized portals with entry buttons on the home page.

#### Features for Providers:

The information available on the sites should help expedite claims processing and payments by keeping providers up to date on policies and procedures.

#### Features of the *Providers* page include:

- AHIN: an introduction to the Advanced Health Information Network (AHIN) for providers who are interested in subscribing to this service for determining eligibility and submitting and tracking claims.
- Claims Filing Guide: information about filing claims.
- Electronic Data Interchange: a section that outlines procedures for submitting claims electronically to USAble Administrators.
- Forms for Providers: a section that links to miscellaneous forms for medical providers.
- **Providers' News**: a quarterly publication that contains detailed information about claims submission, changes in procedures, and other information related to USAble Administrators.

- **Contact Us**: phone and e-mail address information.
- Frequently Asked Questions (FAQ): answers to questions about products and services.
- Network Development Representatives: a list of regional representatives, which provide assistance with questions regarding USAble Administrators.

#### **Company Information:**

Company information is located in sections called "About Us" and "Contact Us." The "Contact Us" section contains a regional office map and directory.

#### **Customized Provider Directories:**

One section of the site that is not available yet will go live by April 1. The "Provider Directories" will feature directories customized to match the member's ID number. When a member enters the member number from the USAble Administrators ID card, he or she will see a page that lists all the networks accessible through that member's health plan. The menu of networks will be ordered from the highest benefit level to the lowest.

#### Navigation Help:

Other areas of the new site that should be helpful to site visitors are "Search" and "Site Map." The "Search" section allows keyword searches of the site (excluding databases), and the "Site Map" gives links to all sections of the site. Spring is just "around-the-corner" and the following allergy services are covered! All benefit plans cover the following if Health Advantage guidelines are followed:

Health Advantage Related Articles:

- Office visits
- Allergy injections
- Serum (covered under the medical benefit, not prescription)
- Testing
- Rast testing (paid based on medical policy guidelines)

Even if a specialist is billing only allergy serum, a referral is still required. (*Except for the Open Access Plan*).

# Please note that syringes for self-administration of allergy injections are not covered under any Health Advantage plan.

## Copy ID Cards:

Don't forget to copy the members' **current** Health Advantage ID Card! Many groups renew with different benefits during the year and benefits often change. Please remember to keep the patient's chart updated with a current copy of the front and back of the ID card.

## **CPAP Machines**

For Health Advantage: Effective December 1, 2001, CPAP machines and supplies no longer require prior authorization as long as the ordering/referral guidelines are followed depending on the requirements of the member's benefit plan. BiPaps and supplies still require prior approval.

#### **Incorrect Denials:**

HMO and POS claims from network providers other than Primary Care Physicians must contain the referring physician's name/provider number and referral number when applicable. Claims received with partial information can cause a claim to deny or be processed

## Open Access Plan:

Two employer groups, Mercy Medical and Town and Country Discount, are on the new Open Access Plan. With new groups being added each month, the members' identification card will indicate Open Access. Members with the Open Access Plan may see a participating or non-participating provider and no referral is required. The benefit coverage applies based on the status of the provider.

Members are encouraged to select a Primary Care Physician. However, it is not required. Please note that a deductible and copayments may apply to participating providers as well as non-participating providers.

# Oral Contraceptives:

Since 1996, Health Advantage has offered a restricted list of oral contraceptives for members. The list of covered oral contraceptives has been recently updated.

Beginning May 1, 2002, the following contraceptives will be the preferred list of covered oral contraceptives:

Ortho-Cyclen Ortho-Tricycline Ortho-Cept Ortho-Novum 7-7-7 Ortho-Novum 1/35 Ortho-Novum 1/50 Ortho-Novum 10/11 Modicon Micronor Ortho-Evra patch Loestrin Estrocept Tri-Norinyl Yasmin

Health Advantage has recently notified members on the updated contraceptive list. If a Health Advantage member is currently taking oral contraceptives, the member will need to consult their physician to change to one of the preferred oral contraceptives mentioned or self-pay for oral contraceptives not on the preferred list. If a generic form of the above-mentioned oral contraceptives is available, the generic will be covered. No other contraceptives will be covered.

# <u>Pended Claims:</u> Waiting for Information from a Provider:

A claim waiting for information from a provider will remain pended for 30 days or until the requested information by Health Advantage is received. The member should not be billed.
